# 2021 \*\* Fall Haul-Out & Winter Storage \*\* 2021

November 1, 2021 to May 1, 2022

## HAUL-OUT RESERVATIONS

All boats that require Spitzer marina to provide haul-out services must be on the haul-out schedule by October 15, 2021.

## WINTERIZATION

If performing winterization on your own boat, you must fill out a Boat Owners Service Form in the Marina Office and follow our specific rules.

## INSIDE STORAGE

All boats for inside storage will be hauled-out and blocked outside for winterization and service needs. On or about November 8th – 10th, 2021, all boats will be moved inside. If your boat has not been hauled-out and winterized by this time you may lose your inside space. You may not work on your boat once it is inside the building. All boats that will be stored inside must not have had their fuel tanks topped off. **ANY LEAKS OR DAMAGE BY FUEL OR OTHER MATERIALS WILL BE CLEANED UP AT THE BOAT OWNERS EXPENSE.** All boats located inside will be removed and placed outside on or about April 1, 2022 for spring preparation and service needs.

## OUTSIDE STORAGE

No electric will be provided in storage areas once winterization is complete. Mast chiming WILL NOT be tolerated this winter – please secure your lines! Outside storage placement will be determined by our staff based on size and spacing needs. All visitors between December 1, 2021 and April 1, 2022 may be asked to sign in with Security. During inclement weather the Marina may close access to specific areas of the facility. **Please dispose of your oil and trash in the appropriate containers.** Oil container located by lift station and trash bins located throughout the yard.

## SUMMER 2022

There will be no SUMMER DRY STORAGE for summer 2022. All boats MUST be launched or removed from the Marina. Any boats left on land after May 1, 2022 will be charged in-water dockage rates if not under dockage contract at Spitzer Riverside Marina.

## HAUL-OUT PREPERATION

All boats must be docked bow forward to be moved for haul-out purposes. Any boat with double engines or outboard engines hanging off the back must be a wait for owner. All personal items on the docks must be removed by November 1, 2021. Any items that are not stored on boat (i.e. golf carts, grills, personal watercraft, dock boxes etc.) will incur additional storage charges.

## CRADLES & TRAILERS

All cradles and trailers must bear the customer's name and the boats OH #'s. Those with no identification or deemed unsafe will not be used.

**No chemicals may be used to clean bottom of boats, water only!**
